Terms & Conditions

ORDER CONFIRMATION

To start production, please reconfirm the order ASAP, within a week at the latest. We take up production only on receipt of your confirmation and receipt of the 50% Advance Payment. Delay in order confirmation can lead to changes in unit prices subject to volatility in the supply of our raw materials.

MINIMUM

The minimum order shipment value is FOB US\$ 2,000.

For orders below this amount, an additional processing charge will apply, by discussion with both parties. Minimum order quantity per different product depends on the specific product.

QUALITY

For any special tests like AZO, CE testing, light fastness, washcare, etc. we will charge extra as per the actual costs involved. Acceptable color variation should be 5 to 10%.

PAYMENT TERMS

50% Advance & Balance 50% CAD (Cash Against Documents), TT (Telegraph Transfer), LC at sight (no deferred LC). The final 50% will be required upon confirmation of product quality by the clients. All advance payments are to be sent by SWIFT.

Sample Development Costs can be sent by SWIFT. All bank charges in the client's country will be to the account of the client.

ADVANCE PRODUCTION SAMPLE

We can courier you representative APS as bonafide free samples to a maximum of 3 piece of each item in about 2 weeks after We can courier you representative APS as bonafide free samples to a maximum of 3 piece of each item in about 2 weeks after confirmation of the order..

If APS/ Salesmen sample requirements exceed 0.25% of the order value, the difference would be borne by the client as Sample Development Charges. The courier costs involved would be for the account of the client. Clients are to advise their courier A/C No. details for dispatch of new/advance production samples.

DELIVERY

The normal delivery period varies between 6-8 weeks after receipt of the advance payment, depending on the order assortment and the time when the order is placed. For repeat orders, it is the same. In view of the volatile prices of raw materials, repeat order prices need to be reconfirmed (which will be mentioned as far as possible) before order placement.

LABELLING & PACKAGING

Clients are to send L&P instructions latest within 1 week after the order confirmation. Any delay here could adversely affect production time and subsequent order delivery. Prices are inclusive of normal wash care and composition labels, plus seaworthy export carton packaging with a carton gross weight of approximately 15-20 kg maximum. Any special labelling and packaging requirements would cost extra.
